Resource:
How to File Your 571-L Business Property Statement



The Assessor is responsible for the discovery and assessment of all taxable business personal property located in Alameda County as of January 1st every year. By law, businesses with an aggregate cost of business personal property valued at \$100,000 or greater are legally required to file an annual 571-L Business Property Statement. Unlike real property, business personal property is not subject to Proposition 13 value limitations and is appraised annually at its fair market value.

Examples of taxable business property include:

- Office furniture and equipment
- Machinery
- Computers
- Supplies
- Property Leased to Others

The 571-L Business Property Statement form provides the Assessor correct information to properly assess the value of an owner's business property. 571-L Business Property Statement forms are due yearly on April 1st. Businesses that do not file their 571-L Business Property Statement are subject to an estimated business assessment and a 10% penalty on their assessment.

Filing can be done by mailing in the paper statement sent out to your business or by filing electronically through the e-filing system. If a business owner owns numerous businesses, separate filling is required for each business location. Most businesses can file their 571-L form electronically.

Filing Information:

Electronic filing of the Business Property Statement uses a web-based application that will allow users to view, modify, and submit their 571-L forms.


Business owners in California may e-file by using SDR (Standard Data Record) or e-SDR. The SDR simplifies the process of filing annual statements by bundling a group of statements into a single file. The SDR system only accepts statements that are filed electronically in the approved XML format. Special programming and/or software is required to create SDR files.

e-SDR is the system that was designed with the small business owner in mind. Statements are filed through an interactive system with instructions. No special software or programming is required. Many computers already have Adobe Reader installed or else the program can be downloaded from Adobe for free. e-SDR is recommended for businesses with fewer than five locations, as each location requires a separate statement. When a business owner or an authorized representative has completed the form, the filer receives an immediate online confirmation of the filing. In addition, a copy can be printed

for an owner's records. It is recommended to keep a copy of the confirmation number as a record and to confirm proof of filing.

Program Eligibility for Renters

- Rental unit must be located in Fremont
- Renter has household income at or below 80% of Area Median Income
- Renter qualifies for unemployment or has experienced reduction in household income, incurred significant costs, or experienced financial hardship due to COVID-19
- Renter demonstrates risk of experiencing housing instability or homelessness

Priority given to households who have experienced unemployment for 90 days preceding their program application or have a household income at or below 50% of Area Median Income

Coronavirus Updates

ALAMEDA COUNTY ALIGNS WITH THE STATE'S INDOOR MASK MANDATE

COVID-19 Information

In alignment with the State, the Bay Area counties of Alameda, Contra Costa, Marin, Monterey, Napa, San Francisco, San Mateo, Santa Cruz, Solano, Sonoma, and the City of Berkeley rescinded the mask mandate for most indoor public settings.

Unvaccinated individuals over age 2 will continue to be required to wear masks in all indoor public settings.

Indoor masking is still required by the State for everyone, regardless of vaccination status in public transportation, health care settings, congregate settings like correctional facilities, homeless shelters, long-term care facilities, and in some businesses, K-12 schools, and childcare settings.

Several California schools had their first school week with the mask mandates lifted that began on March 14th. Other California schools plan to continue a mask mandate in school settings through mid-April. Businesses, venue operators and hosts may determine their own paths forward to protect staff and patrons and may choose to require all patrons to wear masks.

Vaccine Distribution

All Alameda County residents, ages 5+, are now eligible to receive the COVID-19 vaccine in Alameda County. Please be advised that the Pfizer vaccine is approved for persons ages 5+; the Johnson & Johnson and Moderna vaccines are only approved for persons, ages 18+.

Minors between the ages of 5-11 years old are eligible to receive the Pfizer children's vaccine with parental consent. Information regarding the Pfizer vaccine for young children can be found HERE.

Booster/ Additional Dose Information

Pfizer, Moderna, and Johnson & Johnson are currently available as boosters and as an additional dose for eligible individuals.

An additional dose is available for immunocompromised individuals, who completed all necessary doses of Pfizer, Moderna, or Johnson & Johnson after 28 days have passed since their last vaccine dose.

A booster dose of the Pfizer vaccine is available to individuals, as young as 12 years old, who received their second dose of Pfizer at least 5 months ago. A booster dose for Moderna (at least 5 months after their second dose) or Johnson & Johnson (at least 2 months after their first dose) are available only to individuals 18 years and older.

Alameda Façade Grant Program:

The City of Alameda re-opened its Façade Grant Program that provides business and property owners with matching grants to improve their storefronts and enhance the city's retail districts. Under this program, eligible business and property owners may receive matching grants up to \$15,000 for exterior painting, new awnings and signs, and refurbishment of architectural features. Applications are now open. The last application deadline for the 2021- 2022 program year is April 28, 2022. Business Tax Relief

On April 29, 2021, Governor Newsom signed a business tax relief bill that enables California businesses that received Forgiven PPP loans to deduct from their California state taxes all business expenses paid for using the Forgiven PPP loan. To be eligible, a business must have received a Forgiven PPP loan, experienced a reduction in gross receipts of 25% or more in 2020 as compared to the same time period in 2019, and not be a publicly traded company.
